- 3) In order to qualify for the Member rate, your account must be in good standing (no more than 30 days past due), otherwise, you will be invoiced at the regular rate.
- 4) Set up time for EXPO exhibitors will be 9:00AM - noon, so have your booth ready by noon. Take down will be no earlier than 7:00PM, so do not start disassembling your booth until that time. Vendors who fail to adhere to the take-down time may be subject to an additional charge of \$100.
- 5) As an EXPO exhibitor, you will need to have a raffle prize of goods and/or services of no less than \$50.00 in value to be used for a drawing at the event. The drawing rules will be set by you and can be done during or after the Expo. Also, if possible, please provide giveaways with logos such as pens, pads, etc.
- 6) **Booth Standards – There are to be no signage, displays, product nor canopies, tents etc. that goes above the sidewalls or fronts of your booth. (SO PLEASE PLAN ACCORDINGLY). This is to protect the integrity of all vendors and prevent the visual obstruction of every booth.**
